The Government of Andhra Pradesh in the G.O cited, have issued orders regarding insisting on enforcement of bond in the case of an employee of Public Enterprise who joins the Central Government, State Government or Quasi Government Organization or another Public Enterprises, subject to the condition that fresh bond is taken to ensure that the employee serves the new employer for the balance of the original bond period.
