ORDER:

The Eastern Power Distribution Company of Andhra Pradesh Limited hereby accords sanction for the rates of Dearness Allowance to all the employees of APEPDCL in the Revised Pay Scales 2006 and Dearness Relief to the Pensioners/Family Pensioners with effect from 01-07-2009 as indicated below:

i) Dearness Allowance to the employees drawing Revised Pay Scales of 2006: -

a) Dearness Allowance rates from 01-01-2009	:	22.407% of pay
b) Revised D.A rates from 01-07-2009	:	27.782% of pay

ii) Dearness Relief to the Pensioners/Family Pensioners: -

a) Dearness Relief rates from 01-01-2009	:	22.407% of Pension/ Family pension.
b) Revised DR rates from 01-07-2009	:	27.782% of Pension/ Family pension.

2) The arrears of Dearness Allowance as per the increased rates for the month of July 2009 shall be paid in cash along with salary for the month of August 2009 payable in September 2009 to all the employees of APEPDCL.

3) The arrears of Dearness Relief to Pensioners/Family Pensioners as per the increased rates for the month of July 2009 shall be paid in cash along with the Pension/Family Pension for the month of August 2009 payable in September 2009.

4) The Dearness Allowance so calculated be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next rupee.

5) These orders are issued with the concurrence of the Director (Finance) vide Regd. No. 3458, Dt. 21.08.2009.
