## ORDER:

The Government of A.P. in the reference 1<sup>st</sup> cited, have issued a clarification that, for settlement of the cases of stepping up of pay of the Senior Government servants on par with the pay of their juniors as per Rules, the requests/ representations of senior Government servants must be received upto a period of 5 years after the promotion of their junior. Under no circumstances, such representations beyond 5 years after promotion of their junior can be allowed. The APEPDCL in the reference 3<sup>rd</sup> cited, ordered that the orders issued in the Government circular Memo 1<sup>st</sup> cited, shall be made applicable in respect of APEPDCL employees.

2. In the reference 4<sup>th</sup> cited, based on the Employee Unions and Associations request for relaxation of 5 years time limit for applying for rectification of pay anomaly from the date of promotion of their junior, APTRANSCO have issued orders to give one time exemption and give time upto 31.01.2011 to make any representations in all cases where 5 years limitation period is over. Under no circumstances the representations received after 31.01.2011 shall be allowed.

3. After careful examination, the Eastern Power Distribution Company of Andhra Pradesh Limited hereby orders to give one time exemption and give time upto 28.02.2011 to make any representations in all cases where 5 years limitation period is over. Under no circumstances the representations received after 28.02.2011 shall be allowed.

4. These orders are issued with the concurrence of the Director (Fin.&HRD) vide Regd.No.233, Dt.29.01.2011.
